**AN ORDINANCE APPROVING SALARIES FOR EMPLOYEES OF THE CITY OF  
GARY FOR THE CALENDAR YEAR 2012**

**WHEREAS**, Section 36-4-7-3 AND 36-8-3-3 of the Indiana Code, direct that the “Salaries of each and every appointive officer, employee, deputy assistant and institutional head, shall be fixed by the Mayor subject to approval of the Common Council, and

**WHEREAS**, The Salaries of the officers and employees of the City of Gary schedule of which is attached hereto, and made a part hereof, and marked for purposes of identification as “Salary Schedule for the City of Gary for Calendar Year 2012”, and


**WHEREAS**, Sections 36-4-7-3 and 36-8-3-3 further require that all such salaries be fixed on or before the thirtieth day of September for the next succeeding fiscal year,

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Gary, Indiana as follows:

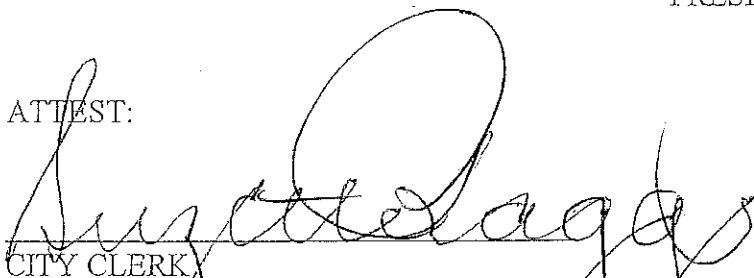

**SECTION 2.** The ordinance shall be in full force and effective beginning January 1, 2012.

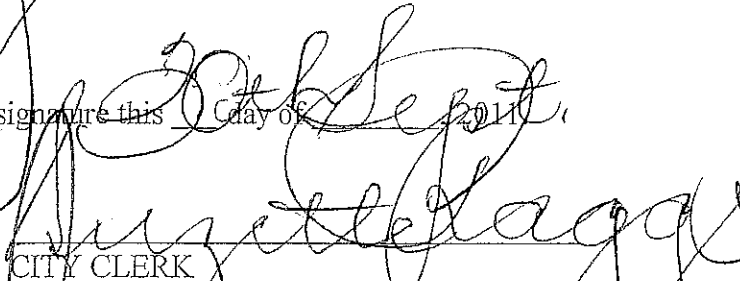

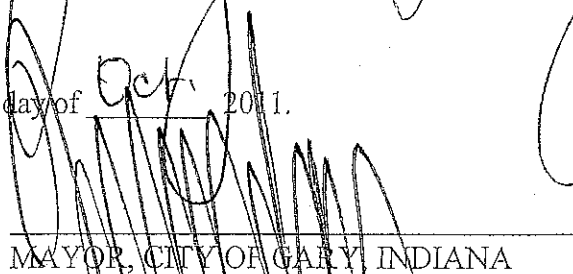
